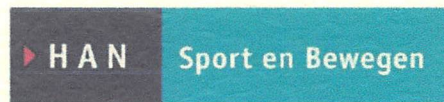


MEMORANDUM OF UNDERSTANDING
BETWEEN
UNIVERSITAS NEGERI SURABAYA, INDONESIA
AND
HAN UNIVERSITY OF APPLIED SCIENCES,
INSTITUTE OF SPORT AND EXERCISE
STUDIES
NIJMEGEN, The NETHERLANDS

This Memorandum of Understanding is made and entered into, by and between Universitas Negeri Surabaya, Surabaya, Indonesia (hereinafter as Universitas Negeri Surabaya) and HAN University of Applied Sciences, Institute of Sport and Exercise Studies, The Netherlands (hereinafter as HAN Institute of Sport and Exercise Studies).

1. Whereas Universitas Negeri Surabaya and HAN Institute of Sport and Exercise Studies desire to engage in cooperative educational and research activities, for the mutual benefit of both institutions, Universitas Negeri Surabaya and HAN Institute of Sport and Exercise Studies have agreed upon the following:
 - Joint research in the fields of mutual interest to both universities; Exchange of faculty members and researchers;
 - Exchange of students;
 - Joint organization of seminars and academic meetings;
 - Exchange of materials in education, and research, publications and academic information.
2. Each activity to be performed under this Memorandum of Understanding shall be undertaken pursuant to an addendum that will contain the specific terms and conditions governing the activity. These terms and conditions shall be mutually agreed upon by the two institutes on a case by case basis.
3. Recognizing that the implementation of any form of academic collaboration depends on the availability of financial support, both institutes shall make their best endeavors to identify and gain access to suitable sources of funding to support the activities proposed in this Memorandum of Understanding.
4. All activities developed hereunder shall be in accordance with all applicable rules and regulations of Universitas Negeri Surabaya and HAN Institute of Sport and Exercise Studies, and all applicable national and local laws, rules and regulations.

5. The Memorandum of Understanding shall be valid for a period of five years and shall become effective from the date when representatives of both universities shall have affixed their signatures to it. Unless either institute gives not less than three months' prior written notice before the expiry date of the validity period, of the intention to terminate to the other institute, the Memorandum of Understanding shall be extended by tacit consent for another period of five years, and so on.
6. The Memorandum of Understanding may be revised or modified within its period of validity by mutual consent. It may also be terminated within that period by either institute giving not less than three months' prior written notice of the intention to terminate to the other university.
